CIRCULAR

The Hon'ble Court, while dismissing SLP(Crl.) No. 9067 of 2016 (The State of Uttar Pradesh vs. Munna @ Deevana & Anr.) on 23.10.2017, has directed as under:

".....in every case filed in this Court against acquittal, the period of custody undergone by the accused should be mentioned. The Registry may take steps accordingly."

Accordingly, it is hereby circulated for the information of all concerned that the Competent Authority has been pleased to approve change in the nomenclature of Col. 7(e) [i.e. "sentence undergone"] of the Proforma for First Listing to "**period of sentence undergone including period of detention/ custody undergone**".
